

other groups. All the co-defendants except Alex and Pat are no longer on house arrest, but still have (less) strict bail conditions. Some were in jail for a month or a few months before being released on bail. The Crown is seeking prison sentences for each of the defendants. The preliminary inquiry is scheduled for Fall 2011 and the trial will most likely be in 2012.

We do not consider the following individuals to be a "group". We include them together as they are co-defendants and get support from Guelph ABC.

G20 Defendants

Update April 15, 2011



On June 21-27 2010, thousands of people took to the streets in opposition to the G20 meetings in Toronto. There were 1090 arrests: the largest mass arrest in Canadian history. On Saturday, June 26, a break-off march in downtown Toronto left behind a path of shattered glass and torched cruisers, a riot that had not been seen in this country in years.

There are dozens of people with serious criminal charges for allegedly organizing and attending the protests. Repression of these folks has continued, including arrests for breach, threatening home visits and surveillance.

Info about a few of the people facing repression and ways to support them follows.

There is currently a Publication Ban which means that details of the cases are not allowed to be made public.

☪ Kelly

Kelly Rose Pflug-Back is a grassroots anti-poverty activist from Guelph. She was arrested over the G20 weekend on conspiracy charges and released on bail. On July 21, police issued a news release announcing that she was wanted for 6 counts of mischief over \$5000 from the G20 protests. After weeks in jail, she was released on strict house arrest bail conditions. Her conspiracy charges have been since dropped. She remains on house arrest far from her friends. ☪ Ryan

Ryan Rainville is an indigenous anarchist who was arrested at the G20 and released on bail. About a month later, he was rearrested on more charges related to the G20 including mischief and assault. He was in jail for almost three months and was rejected bail multiple times. He was finally released on bail on November 9th with very strict conditions. His trial was on April 12, 2011 and awaits the verdict and sentencing on May 31. You can send mail to him through Guelph ABC.

☪ Conspiracy Charges

Eighteen people are charged in relation to organizing against the G20 summit. Their charges include: conspiracy to commit mischief over \$5000, conspiracy to assault police and conspiracy to obstruct police. Some are accused of being part of Southern Ontario Anarchist Resistance (SOAR), as well as
